

ELKIN MUNICIPAL POOL MEMBERSHIP FORM

POOL RULES & REGULATIONS

- No diving in shallow end (this includes flips, etc.). Dive in 12 feet only.
- Entry into the diving well is only allowed through the diving board or the slide. Patrons are not allowed to access the deep end for swimming during public swim unless from the diving board and slide.
- No Coolers
- No cartwheels or handstands off side.
- No backwards anything off sides of pool.
- No diving under ropes (lane ropes included).
- No running.
- No horseplay (dunking, pushing, splashing, anything rough and at Lifeguard/Staff discretion).
- No public displays of affection.
- Kickboards, flippers & weights are for lap swimmers, swim team and lessons only.
- Swimmers may not walk on deck with flippers.
- Pool toys may only be brought out if not busy and at the discretion of the pool manager.
- Only 'Nerf/soft objects may be brought to throw and only if they are not a nuisance to others and only allowed at Pool Managers discretion.
- No water guns.
- PFDs are the only floats allowed (no sit-on rafts or arm-floats).
 - Parents or Children that cannot swim may check a PFD from the Office. If they decline, then they must sign a waiver declining the PFD. (Located in Office Handbook)
- Absolutely no personal floatation devices in the deep ends.
 - Anyone wearing a PFD must be supervised by an adult at all times.
- No chicken (no one allowed on anyone's shoulders).
- No hanging or pulling up on starting blocks. Blocks are used only for swim team and lessons.
- No hanging or sitting on safety lines or lane ropes.
- No jumping or diving off ladders.
- No glass in pool area.
- Food and drinks are to be kept on the pool deck.
- No smoking or alcohol.
- Proper bathing attire must be worn at all times. No cut-offs, or pants are allowed. (Bathing Suits Only)
- No one is allowed in pump rooms; pool office and concession stand but staff.
- The pool will operate in rain as long as staff can clearly see the bottom and not under threat of severe weather.
- No lingering at or under guard stand.
- All children in diapers must be in swim diapers or rubber pants.

Diving Board and Slide Rules

- Only one at a time on board.
- One bounce per dive.
- Exit immediately using closest ladder or by swimming under rope.
- No swimmers allowed in diving area when board and slide are in use.
- No cartwheels, handstands, suicides, flying squirrels, cut-aways or seat drops off board.
- No face masks may be worn when jumping or diving off board.
- No jumping or diving towards the side.
- No one may catch someone off board.
- No flotation devices may be worn when using board and slide.

I/we do further understand that my/our use of a season pass is subject to the following conditions, requirements and policies: 1. Passes are valid for GENERAL PUBLIC SWIM SESSION ONLY, which requires a minimum of 10 swimmers. 2. Town sponsored events/programs have PRIORITY USE OF POOL TIME. 3. ANY change in the posted schedules will be advertised at the pool facility prior to the change. 4. Entry to the pool shall be subject to the maximum occupancy posted and may be denied or delayed for safety, equipment, weather or other reasons. 5. PASS FEES ARE NON-REFUNDABLE, NON-TRANSFERABLE AND WILL NOT BE PRO RATED. 6. A SEASON PASS IS VALID FOR ENTRY DURING MAY, JUNE, JULY, AUGUST & SEPTEMBER. (NOTE: DUE TO STAFFING ISSUES, THE POOL IS TYPICALLY ONLY OPEN ON WEEKENDS IN AUGUST AND SEPTEMBER WITH THE SEASON CLOSING ON LABOR DAY.)

I hereby give the above written swimmer/participant permission to participate and be involved in Elkin Recreation & Parks Department Swim program.
